





Four Ways To Boost Your Hunting Dog's Muscle Health

Hunting dogs need to be quick enough, strong enough, and agile enough to keep up with the physical, fast-paced demands of the sport. Naturally, speed and agility go hand-in-hand with muscle health—the stronger your dog's muscles, the better he/she will likely perform.

To boost your dog's muscle health, here are four things to consider:

Exercise

While this one may feel like common sense, it's nevertheless important to address that physical activity is crucial for maintaining and growing strong, healthy muscles. Examples of canine exercises include walking, jogging, playing fetch, practicing agility, or swimming. Your dog may enjoy a combination of all! For hunting dogs, it's especially key to focus on running, considering its ability to build endurance; some experts suggest that hunting dogs should train by running 2-3 hours a day.

I'd also recommend focusing on resistance training, such as uphill walks or runs, to boost muscle mass.

Diet

An improper diet could lead to weight gain as it often leads to fat build-up in the body. Body fat can cause inflammation, which may result in joint pain and lower energy levels. Because both side effects could hinder a hunter dog's performance and potentially result in muscle atrophy (if the pain/fatigue deters your dog from exercising), providing a nourishing, nutrient-rich diet is a must. Opt for a dog food that is as minimally processed as possible, and ensure that it contains the right muscle-supporting balance of protein, fat, and carbohydrates. You can work with your veterinarian to determine what ratio would best support your dog's training and muscle-building needs. Provided your dog doesn't have any conflicting health issues, a high-protein diet can be valuable for building muscle. I strongly suggest that these proteins come from wholesome, high-quality sources.

Supplementation

Fortetropin, a natural, muscle-supporting ingredient, could be a very helpful addition to your hunting dog's supplementation regimen. It has been clinically proven in multiple studies to increase muscle growth and reduce the risk of muscle atrophy—a

win, win. Gaining and maintaining healthy muscle mass is an important way to support your dog's speed, mobility, and stamina while hunting. Additionally, preventing muscle loss will be just as important as dogs get older. Throughout recovery days and off-seasons, being able to preserve the muscle mass that you and your dog worked hard to build will be invaluable. This means that less time and effort can be spent working to rebuild it. To reiterate, this supplement can provide your dog both growth and retention benefits. Since Fortetropin is derived from fertilized egg yolk it's a completely safe, food-based ingredient. Being all-natural, it has not been shown to have any contraindications. (Note: if your dog has an egg allergy, speak with your veterinarian about the suitability of using this product.)

Physical Therapy

It's a common misconception that canine physical therapy is only useful when a dog is recovering from injury or musculoskeletal issues. However, physical therapy can actually be a great tool for building targeted muscle growth and strength (via underwater treadmills or disc work, for instance), as well as for increasing range of motion (via PROM, which stands for Passive Range of Motion). Because hunting is so demanding on the body, physical therapy can also help assess your dog's limb alignment and readjust as needed so that your dog stays as healthy as possible.



Chance Happenings By Doc Skinner

Was talking to my friend Larry Adams one day, he mentioned how chance happenings or lucky breaks can result in the beginning of a successful breeding program and I agreed. This was even more evident when, two articles caught my eye in the November H&H. It was one of the Yellow Creek stories, and Rev. Parks Pearson Creek Story. Let me further elaborate. I have been an ardent fan of Yellow Creeks since I was twelve years old and had a grandson of Yellow Creek Jack. Every popular breeding kennel can trace back to Yellow Creek such as Sutton, Linesman, Pleasant Run, Biplomat, CarE Line Buddy, Wilcliffe, Argo, and Pearson Creek.

Let me tell you about my own Chance Happenings, I had a fellow beagler that was a pharmacist, and I would often stop by to talk dogs with him. This particular time he was on the phone and he was shaking his head. I said "What's happening?" He informed me that he was inquiring about a FD CH by Wildlife Boogie FDCH, but he had been sold and now he is trying to sell me a young male. Curious, I asked him how much he was asking. He said four

hundred dollars. I said tell him I will send him a check and he can send me a dog, Goodwin's Bannister. He never finished, but he produced about 8 champions locally and many of his offspring were producers and were winning places at the major derby and futurities. I guess AL Stienke noticed because we struck up a conversation that resulted in a strong friendship.

My second happening took place at the Southern futurity, where two of Goodwin Bannister's males won two seconds. Rabbits were very scarce off the club grounds, but I found a spot to breeze a female I owned by Goodwin's Bannister. Pearson Creek Stub won the Derby trial, and I went out to see him perform and was very impressed. George Nixon came up to me, I had never met him, and he said, "I heard you know where to find a rabbit to give some dogs a run." I said, "Get your truck and your dogs and lets go." I found that same rabbit and he ran all six of his dogs. One the way back, I got an idea. I said, "George, I did you a favor, how about doing me one?" He said, "What is it? I have a futurity female that should be in heat in a couple of weeks, would you take her home with you and breed her to Stub?" George said, "Sure." I got two females out of that litter that produced six field champions between them. Two amazing performers came

out of one of the Stub females and Del Hart Coconut. Mill Road Stubborn came back fourth in a class of 104 futurities and defeated the four hounds above her one at a time. Her sister, Del Hart OJ, was back sixth that day, and she later won the Pa State Championship in a class of over one hundred. At the age of eight, she won a trial for champions that was judged by Curt Blinsinger, and the inimitable Mr. Sutton. This was the last trial that Mr. Sutton had judged. Their brother, Del Hart Trap, won the Eastern Derby prior to which he had won ten consecutive derby trials. I cannot even estimate how many FDCH traced back to these two Stub females. Not to slight the Connell's, but Connell Checmate won the Eastern Futurity and produced Mill Road Flow, the most accurate beagle I ever owned. It was a heck of a ride from my two Chance Happenings.

Starting with trials advertised as of January 1, 2021, all licensed trials advertised in this magazine will count for this award. Here's How It Works:

- Trials must be advertised between page 1-64+ with this magazine in order to count towards this award.
 - Field Trial results are due within 14 days of the trial held.
 - Updated point standings will be posted monthly at beaglersmagazines.com.
 - The award runs from January 1st-December 31st.
- All four classes will have a top hound that will receive a jacket, trophy, and an article on your hound in the March 2022 issue. Top Producing Sire and Dam will also receive this award package.
- The overall highest point recipient of the (4) classes will be titled the High Hound. This hound will receive in addition to his/her class prizes, a check for \$500 made possible by the club ad submissions.

How The Points Work:

In order to qualify, a hound must have at least one win in any licensed AKC or CKC trial.

The Yellow Creek Story

By: L.M. (Yellow Creek) Watson

Ch. 2 – Hunting Quality

As I have said repeatedly, the first thing I look for in a hound is level-headedness. Often, it is possible to pick from a litter of youngsters one or perhaps two that stand out when it comes to this all-important quality. Closely allied with intelligence in hounds, level-headedness spells the difference between a mediocre hound and one of top grade.

It always shows through a youngster's eyes when he is yet a puppy if one knows what to look for. When you speak to such a hound, he will look at you with an interested expression that seems to indicate he is trying to understand what you are saying to him. Sometimes, the easiest

way to locate such a puppy in a litter is to eliminate from consideration one by one those that do foolish things, or that do not have a sober, understanding expression. Watching a litter of puppies, behave erratically, or that indicate in little ways that they are inferior to others. I never bred such hounds when they turned up in spite of what they might do in the way of field work later on.

There are other ways in which hounds indicate the use of intelligence and level-headedness. For instance, I have never known a male hound that was overly interested in females that were not ready for breeding to be worth anything in producing. On the other hand, a male that will not pay any attention to a female nearing her heat should be sidestepped in a breeding program. Such hounds are not sensible and will pass the poor traits on to their youngsters.

I begin early in deciding whether or not a litter of puppies has good common sense and is sensible. As they grow up, I continue to watch and make certain my observations are in line all the way. Yellow Creek Bob, Yellow Creek Bobbie and Yellow Creek Sport stood out as puppies to me very clearly. They obviously were not common dogs, based on their demeanor about the yard, and in their pens as youngsters. Later on, their use of good sense was necessary when it came to settling down and picking checks under pressure, or after a sight chase.

A hound must have plenty of courage if he is to be a good one in my book. He must have the desire to go out and hunt and hunt, and the courage to back up every inch of it. I don't like a hound that will back down from a fight if the fight is foisted on it by another. On the other hand, I don't like a hound that starts fights. A hound that will not back down, no matter what the odds, is a real one if he has ability, and is worth more than a million of those that will cower down in fear. A hound that constantly wants to fight is like a person who wants to fight all muscle and no brains to speak of.

I like a hound that is close, but not over exacting to a point where speed is sacrificed. It is important that a hound stays in to do his work where a rabbit might be frozen tight and sitting hopefully, or where the hound will not be starting other game, but let us not make so much of this method idea that we sacrifice the hob we set out to accomplish, and then lose perspective....let us see the entire forest, and not dwell at too much length on an individual tree or two. A rabbit runs ahead of hounds much like a fox. When fox hounds are right up close to a fox, he runs a larger, faster circle, and he is in trouble unless he does so. He does not dare, as a rule, to hop around from tree trunk to jump and so forth, trying to obliterate the trail with intricate hazards. Take a slow running pack sometime, and drop in a few good, fast hounds and watch the run change! The same is true of running rabbits, except in the case of young rabbits, or where rabbits are run in exceedingly thick cover. Many times, a rabbit will hop around ahead of pottering hounds and make a fool of them. In my experience, pottering hounds lose far too many rabbit to suit me, since a smart rabbit will eventually wind up the trail until it cannot be unraveled, eve by the

sharpest nose, and when hounds are working over the same area of cover too long, losses must ensue. I like to see hounds do ways moving their line forward as swiftly as scenting conditions and their won nose will permit it to be moved.

Some hunters prefer slow hounds on the theory that a slow hound will make it possible to kill more rabbits. This generally is a fallacy, though if a hunter is a poor shot, who prefers a rabbit to come hopping slowly to the gun, it might work better to have a slow hound. In general, while a slowly trailed rabbit will make a shorter circle, a swiftly driven rabbit will return to the gun in less time. Often those who prefer slow hounds have never owned a good fast one, and this may well be the case since there are many fast hounds, but not many good, fast ones. A clean, fast hound is obviously indicating more talent for his job than a slow moving one under the same running conditions. The goal is to bring the rabbit around in the shortest time with the least losses, and there can be no questions but that the fast, clean

hound excels in that department.

Style can be overdone to a great extent and is overdone too much to suit me. Results are infinitely more valuable, and if field trials were properly held, results would have to be considered of prime importance. A profoundly good hound will not lose rabbits very often. He may have to commit an occasional breach of space-etiquette here and there when scenting conditions, he may not; but in such cases where there are good reasons for a hound to get out and find where the rabbit went, he should be permitted to do so without any demerit whatsoever, provided he works out in a manner that is indicated, by conditions. Where scenting is obviously though, a hound will have to get out and find the line before the scent is gone altogether. If he leaves a rabbit sitting near the end of the line, and then must come back afterward to jump him again, that is not nearly so bas as that he work too close and so exactingly that he lose the line entirely when the rabbit did not elect to sit in close to the check area! I tis impossible for a judge of hounds which are running braced, to weigh all these situations, of course, and this is an important consideration more to the hound man who wants to develop good hounds than to any field trial judgement factor.

Yellow Creek Sport didn't lose a rabbit once a week and that is no exaggeration. Many of my best hounds rarely lost a rabbit, and that is one of the best indications I know that a hound is running all right. I cannot subscribe at all to any theory which permits a hound to lose game and still place at field trials, or to be considered a good hound, and especially that hound should not be bred into a line of good hounds that do not lose game. Losing game is a large subject. It involves not altogether style, but good running sense and rabbit sense, patience, good nose, and many factors that are subtle and not understood completely by anyone. Suffice it to say that no matter how perfectly your hounds appear to run rabbits, if they lose many of them there is something wrong. You can get that quality of losing game into a kennel or a strain of hounds the

The chief essential of a rabbit hound, or any kind of hound, is to trail the game until it returns, and surprising as it may seem to some field trial judges, that quality can be found in hounds provided it is sought out and proven in the proper manner. It admittedly requires more time than just the few minutes provided for testing in today's field trials.

I consider a hound's voice as being most important. I definitely like a bawl voice, and I want it deep and strong as a hound's voice should be. I do not like a chop-mouthed hound because after looking over many hundreds of hounds with different voices, I have found those that have the machine-gun chatter will bark good bawl voice. If a hound does not have sense enough to know how to handle his bawl voice without letting it work to his disadvantage, he is just another hound. I once had a foxhound that had a bawl-mouth that was long as it was excellent in quality. It was so long a note that from the time he opened until he stopped, you could count to 13 at medium speed and he led the pack hour in and hour out. For every hound with a bawl voice that used his tongue improperly, you will find a dozen chop-mouthed hounds that will do likewise.

Hounds today tend to be much too mouthy, in my opinion. It is not difficult to state when a hound is using his mouth properly, or when is is using it the wrong way. Scent should be the only trigger that sets off a hound's tongue. There is no other reason for a hound to open whatever. You will see many hounds that let go with a lot of talk while harking to a bracemate or packmates, when they have no scent whatsoever and are just plain overanxious and impatient. These hounds should be cut out in a hurry. I will not excuse a hound for tonguing when he does not actually have scent that he can smell for himself.

Worse than over-tonguing is a hound without enough tongue. Some hounds just don't ever have much, and others learn to keep quiet from being overly competitive. A hound that will not give his

packmates the benefit of his work, yet capitalizes on theirs, is a good one to be eliminated from any competition.

In general, a pack of hounds that will go out to run rabbits and wheel them around in an "I don't mean maybe" manner without cheating each other are good ones. I once had five females at Johnny Wyatt's place at one time that were about the fastest five you ever saw. There were a mother, Yellow Creek Gyp, and four of her offspring, Yellow Creek Molly Cricket, Sparky, and Sally. The cover in that area was white oak timber without too much dense brush and those five hounds could outrun any group of its size I ever saw. When the pups were just a year old, they killed many rabbits daily, and during the entire time they ran together, they killed a fantastic number. It would be hard to beat those five hounds.

One quality I always insisted on breeding into my hounds is the desire to hunt. When it gets so a man has to wade through hip-high briars while his hounds wait around outside for him to jump the rabbit, that is too much! All of the sires I used had the quality, and especially did Seminole Ben, Yellow Creek Bob & Sport, and Muskeag Sportsman before them.

I always like to have hounds that will bark "tree" at a hole or den, whichever the case may be. This is easily obtained if you have one that will bark at a hole to teach the rest. Also, it can be quite effectively bred into a strain of hounds, since many will bark tree without any training, once hounds that will do likewise have been introduced into a strain.

Hunting quality is what beagles were originally bred for, and any steps that tend to minimize the importance of these qualities, or to reduce them from consideration in breeding, will do a great deal of damage to the breed.



The Back Room

By Rev. John Parks

CHARTING THE COURSE

If you were going to take a trip by auto in the old days, you would get out the maps of the area you planned to cover and trace out the route on the best roads and in the shortest distance possible. Nowadays you would consult with your GPS program either in your computer or vehicle. If at all possible I like to see where I am going either on paper or on a screen in front of me.

In the old days many beagle breeders didn't plan very far ahead. They just consulted with HOUNDS AND HUNTING to see what producing stud dogs were around close to them and then they proceeded to breed their females to a male that they thought would produce good pups, and hoped for the best.

Now you know that I like to study pedigrees to see what is behind a hound. Some have made fun of me for what they see as my obsession. Nevertheless, I always tried to evaluate all of the possibilities graphically if possible. I used to make out little pedigrees of my females on 3x5 cards, and then would match them up with the card pedigrees of possible males to see how they matched up. Hopefully I could find a male that was related to a hound in my female's pedigree, and that would concentrate the blood that I liked.

Some time ago I came upon a little breeding chart among my old papers that had to be more than 40 years old. In an article that I was writing at the time on breeding methods, I drew a rough sketch of part of that chart and included it with the article. Well, it got shrunk down to one-tenth of the original size that I sent in and put down in the corner of the article, and it was not clear to the readers at all what I was talking about. So, I am going to try again, and this time I took a picture of the chart with my iPad and am including it now. I hope this time it makes it in it's original size, or at least not miniaturized. Here is the Chart: (AT RIGHT)

The title of this chart was "Practical Line Breeding Chart" and under that name was: "Baddour Brothers" and the address on it was Lebanon, Tennessee. There was a small drawing of a rabbit (as you can see) at the top. At the time I tried to contact the original authors for permission To

use it in an article but was unsuccessful. However, since then I have seen it in two or three places in articles I have seen on line, so with that in mind I am Sharing it with you.

Now I must clarify first off, that as far as I am concerned, this is not a "Linebreeding" program as it says. In my mind, line breeding is carried out with the intention of increasing the influence of ONE outstanding ancestor. As you know, I have defined Linebreeding as: "The mating of individuals that are closely related to the same ancestor, preferably an outstanding individual, in order to perpetuate his or her qualities." In doing this, the two individuals being mated are bred "in line" with that common ancestor. You will remember also I have

pointed out that when a breeder states that his (or her) dog is Linebred, you should immediately ask "Linebred to what?" That will help you to determine just what is behind the hound.

With that in mind, let's take a look at the chart. It is a way to perpetuate two distinct lines, and along the way there will be a degree of inbreeding to a greater or lesser degree. However, the blood of the original two lines are maintained throughout the program. This can be accomplished much easier with rabbits than with Beagles because the generations are turned over much more quickly. Besides, few breeders would actually follow through with this, because each generation of hounds would have to prove themselves before

the breeder could select the hounds to breed and move on.

If you study the chart carefully you will see that thIs system produces Three distinct bloodlines of individuals. One in which the blood of the male line is predominate, another in which the blood of the female line is predominate, and finally still a third, which contains half of each original parent.

Will it work? Theoretically yes. Practically maybe not. It depends on whether "Mother Nature" cooperates or not and the genes combine as intended. However, I know a breeder of show rabbits personally that has practiced a program similar to this for TEN generations and is still going with more winners every year. I must note though that he has culled out the inferior individuals rigorously every generation without fail, before moving on.

Well, those are the salient facts. You can do with it whatever you want, I'm just here to keep you thinking; but you will have to admit that it is an intriguing system of planning to keep the good ones comming! Until next time, keep 'em running!






